- **Dates To Put On Your Calendar**

There is **NO SKATING** on the following days:

- **Monday, March 29th – Friday, April 2nd (Skating resumes Monday, April 5th)**
- **Monday, May 31st** (Memorial Day)
- **Friday, June 4** (TC Cherry Classic Competition)

- **Session Requirements:**

- Must be a regular TCFSC member (must have paid the annual TCFSC membership fee of \$80)

Low Sessions * Skaters must have passed Basic Skills 4 up thru Preliminary FS

Open Sessions * Skaters must have passed Basic Skills 4 up through Senior FS

General Sessions * Skaters must have passed Pre-preliminary moves up through Senior FS

- FS, Dance, and Moves allowed on all low, open, or general sessions.

- **Drop in ICE**

1. TCFSC Drop-ins will be at \$22.00/hour.

- **Punch Cards:** A 250 minute punch card is available for \$90 (\$21.50/hr). Skater must be a TCFSC member and must be registered for at least 1 regular spring session to be eligible to purchase a punch card. Punch cards expire at the end of the session (June 18, 2010)

- **Payments**

Payments are to be made by the 15th of each month **exception is the final payment in June is due by June 1st**. Skaters with past due accounts (one or more month's in arrears) **will not be allowed** to skate until their account is made current, and a \$15.00 late fee will be assessed to your account for each month you are in arrears.

Comment from the treasurer on payments. Club payments need to be made on a timely basis, and if you make additional payments or participate in any fundraising events these payments will be applied to your final payment. For example, if your total spring bill is \$1000/4 payments your monthly payment would be \$250.00. If you were to pay \$500.00 in month one you would still be responsible for paying \$250.00 for your month 2 payment and not have to pay your final payment. It is imperative that we have enough money in the club account to meet our current obligations. If you have any questions or concerns please see Cathy.

Any skater whose account is not paid off by June 1 will not be allowed to register for summer. Families needing exceptions to this policy must address the TCFSC Board in a closed meeting.

Spring registration forms may be dropped off in the TCFSC office anytime between now and **February 25, 6pm**. Any registration forms submitted **AFTER** February 25 will be assessed a late fee of \$40.

In the event of filled sessions, registration will be honored on a first come first served basis.
